### Rules for Abstracts

Abstracts within 1 page of A4 format are presented in English in electron variant. Text is printed 1,5-spaced (upper, lower spaces - 2,5 cm. Left space - 3 cm, right space - 1 cm. Paragraph - empty line). Title, dateline, and list of references are printed in 1.0 space. The last name of the presenting author is underlined. The title is made of capital letters. Then in 2.0 space follow the last names and the initials of authors, the institution name, the city, the country, the E-mail address. After the dateline in 2.0 space the text and the list of cited references should follow.

The text of the abstract should be made in Microsoft Word for Windows, type family Times New Roman, point type 12.
